A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Liberty Preservation Act of 2014**

3 FOR the purpose of prohibiting an agency of the State, a county of the State, an
4 employee of the State or a county acting in an official capacity, or a member of
5 the Maryland National Guard or the Maryland Defense Force, on official State
6 duty, to knowingly aid an agency of the United States in the detention of a
7 person in accordance with a certain federal statute; providing for the application
8 of this Act; and generally relating to the detention of individuals.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Public Safety**

17 **13–511.**

18 **(A) THIS SECTION APPLIES TO THE FOLLOWING PERSONS AND**
19 **GOVERNMENTAL ENTITIES:**

20 **(1) AN AGENCY OF THE STATE;**

21 **(2) A COUNTY IN THE STATE;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(3) AN EMPLOYEE OF THE STATE OR A COUNTY ACTING IN THE**
2 **EMPLOYEE'S OFFICIAL CAPACITY; AND**

3 **(4) A MEMBER OF THE MARYLAND NATIONAL GUARD OR THE**
4 **MARYLAND DEFENSE FORCE ACTING ON OFFICIAL STATE DUTY.**

5 **(B) A PERSON OR GOVERNMENTAL ENTITY MAY NOT KNOWINGLY AID**
6 **AN AGENCY OF THE UNITED STATES IN THE DETENTION OF A PERSON IN**
7 **ACCORDANCE WITH §§ 1021 AND 1022 OF THE FEDERAL NATIONAL DEFENSE**
8 **AUTHORIZATION ACT FOR FISCAL YEAR 2012.**

9 **(C) THIS SECTION DOES NOT APPLY TO PARTICIPATION BY STATE OR**
10 **LOCAL LAW ENFORCEMENT, THE MARYLAND NATIONAL GUARD, OR THE**
11 **MARYLAND DEFENSE FORCE IN A JOINT TASK FORCE, PARTNERSHIP, OR**
12 **OTHER SIMILAR COOPERATIVE AGREEMENT WITH FEDERAL LAW ENFORCEMENT**
13 **IF THE AGREEMENT IS NOT FOR THE PURPOSE OF PARTICIPATING IN A**
14 **DETENTION DESCRIBED IN SUBSECTION (B) OF THIS SECTION.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2014.
