The term "Special Orders" has multiple meanings which cannot always be derived from the amount of information we can present here. The "Special Orders" vote may reflect a vote on an amendment or series of amendments to a bill which may dramatically alter the original intent of the bill. "Special Orders" may also reflect procedural motions. The information is provided here for completeness. All floor votes in both the House of Delegates and the Senate are included with the exception of quorum votes.
